Bill informed Lester that severe rainstorms in the area had caused The Little River to flood, wiping out a section of 16" ductile iron water main in the process. In order to restore service to thousands of customers, the town needed to cut in a 16" butterfly valve so that the system could be operated on both sides of the river. After assuring Bill that Team EJP would be able to supply and help install the new valve, Lester phoned Springfield Serviceman Ken Holhut at approximately 11pm and told him what needed to be done. At 7am the next morning Lester and Ken met Bill and his staff at the jobsite. By 3:30pm, a 16" butterfly valve and two 16" Romac 501 ductile couplings were securely installed and service had been restored to the entire town of Putnam. Here in PEPtalk, we talk a lot

about our willingness to drop everything and do whatever it takes. Real stories like this show just how much we mean everything we say. Well done Springfield!

# *In Memory of Herbert E. Sargent*

Herb E. Sargent wasn't just a respected pioneer of the construction industry, he was a legendary entrepreneur in the state of Maine. On April 9, 2006 Team EJP was saddened to learn of the passing of this long-time customer and friend just two months after his 100th birthday. As his grandson, Herbert R. Sargent said: "You'd think he wanted to get to his 100th birthday and call it good." Good

indeed. Herbert E. Sargent founded the H. E. Sargent construction 80 years ago when he dropped out of college and bought a used dump truck for \$75. The company began its historic rise to prominence during World War II by winning defense contracts to build runways. This experience would later lead to several highway construction jobs throughout Maine. In 1988 the company was sold to French construction company Razel. Through a series of mergers and acquisitions, it became a subsidiary of a firm owned by a German construction conglomerate before the Sargent family reacquired ownership last year. Herb E. was a devoted family man who loved spending time with his children and grand-children. Team EJP's relationship with H.E Sargent goes back to 1955 when Everett J. Prescott and Herb E. Sargent worked on their first project together and continues to this day. We extend our deepest sympathies to the entire Sargent family.
